By checking the box below, you agree to the following RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT:

I understand that participating in this event is potentially hazardous, and that I should not enter and participate unless I am medically able and properly trained. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event. I also am aware of and assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, effect of weather, traffic, and conditions of the course and road areas, and intending to be legally bound, do hereby:

- Waive, release, forever discharge, indemnify, hold harmless, and covenant not to sue Summerfest Foundation, Inc., (Milwaukee World Festival, Inc., d/b/a Summerfest), Vision Event Management, LLC, Froedert Health, Medical College of Wisconsin and Medical College of Wisconsin Affiliated Hospitals, and their respective officers, directors, employees, sponsors, and agents; USATF; and the City of Milwaukee, Milwaukee County, the State of Wisconsin, the Wisconsin Department of Transportation, or any other political subdivisions or agencies of government that own or operate portions of the course and road areas, BMO Harris Bank N.A., Bank of Montreal, their parent, subsidiary, affiliated and successor companies and each of their respective officers, directors, agents, representatives, shareholders and employees (collectively, the "Released Parties") from all liability or claims including, without limitation, fees and expenses, whether in law or equity, known or unknown, resulting from, arising from, or incurred with respect to participation in the event.
